IMPORTANT INFORMATION

- To transfer ownership, the beneficiary must apply for a certificate of title within 120 days of the death of the owner.
- For an owner to successfully add a beneficiary:
 - Motor vehicles, trailers or semitrailers can only have one owner (sole ownership).
 - Motor vehicles, trailers or semitrailers can NOT have a recorded lien on the title.
 - The beneficiary MUST be an individual, NOT a business entity.
